Our planning process was supported by a local consulting firm, Quinn Strategy Group, who interviewed stakeholders and led the Board and staff's in-person and virtual planning meetings. To no one's surprise, we affirmed we're a passionate group and care deeply about our work so you can imagine there were a few intense planning meetings. The final product builds on and expands the work of our organization's first two years, pushing us to scale-up existing work while stretching us to continue to operate in new and innovate ways. Forever Maryland advocated, in both Annapolis and D.C., for land conservation funding and environmental legislation that will positively impact state preservation goals and efforts. The Keep Maryland Beautiful grants program was as robust as ever, and we became the fiscal sponsor of B-GREEN, a regional capacity building initiative collaborative in Baltimore City and inside the Baltimore beltway.

# **Pillar I: Education**



Hosted **two** two-day **conferences** (Harford county Ripken Stadium, July 2021 & Ches. Bay Beach Club, Eastern Shore, June 2022) to over 250 attendees.



Provided **five** *Building Better Boards* virtual workshops to 78 attendees including 24 Board members from 44 land trusts, nonprofits, and government agencies representing land conservation and watershed groups.



Hosted **five** successful **webinars** on Regional Conservation Partnerships, geospatial analysis, conservation funding, and more, featuring national and state leaders.

# **Pillar II: Outreach**



Managed the **Keep Maryland Beautiful Grants** Program and, in conjunction with our partners, awarded **\$320,000** to 85 nonprofits, land trusts, and municipalities to support and protect natural resources in 21 counties and Baltimore city. # **Pillar III: Advocacy**

### **MARYLAND GENERAL ASSEMBLY**



Forever Maryland pushed for legislation that resulted in funding additional positions to expedite land conservation, including:

3 positions at the DNR's Dept. of Planning & Acquisition and 2 positions at the Office of the Attorney General.



Testified for support of the state's budget to include more than **\$380 million** allocated for parks and open space.



Testified on **11** critical pieces of legislation, including: the Conservation Finance Act, Maryland the Beautiful Act, Great Maryland Outdoors Act, Irreplaceable Natural Areas Program Establishment, Heirs Property Act and more – all of which significantly impact conservation and preservation goals/efforts.





## **Partners for Open Space**

Continued as the fiscal sponsor of *Partners for Open Space*.



Developed and hosted a *Program Open Space (POS)* Workgroup that included the state's **25** most prominent agricultural, environmental, conservation, parks, and forestry groups. The majority of recommendations from this group were made into law.



Played a critical role in advocating for the payback of previously transferred POS conservation funding.



## **Federal Lobby Days**

Led the Maryland delegation in May at Land Trust Alliance's Lobby Days and participated within the Choose Clean Water Coalition virtual Lobby Day in March.




