HOLD HARMLESS RELEASE AND WAIVER OF LIABILITY AGREEMENT

Forever Maryland is taking measures and precautions to assist you to voluntarily participate in the in-person **Succession Planning Workshop – Passing the Baton**. [Forever Maryland](#) and the official event venue are implementing the following precautions for the conference:

- A mask must be worn in accordance with all federal, state and local/venue requirements/mandates.
- Social distancing will be enforced during the event and seating will be arranged accordingly.
- Hand sanitizer will be made available throughout the facility.
- Food and beverage will be served in a manner that minimizes contact between attendees and service staff.
- Attendees are expected to act in a responsible manner and to observe and comply with all COVID-19 safety protocols.
- Attendees will be required by the venue to self-report any potential symptoms of COVID-19.
- Workshop attendees are encouraged not to risk exposure to COVID-19 in non-official workshop venues.

By submitting this attendee registration either personally or through the designated representative for my county/municipality/company/organization, I acknowledge and agree: (1) that an inherent risk of exposure to COVID-19 may exist at the workshop, despite the precautions implemented; (2) to assume all risks associated with exposure and infection by COVID-19 while attending Forever Maryland events; (3) on behalf of myself and my personal representatives, heirs and assigns, to release, waive, discharge Forever Maryland, and/or any official host venue, their respective officials, officers, directors, employees, volunteers, contractors, sponsors, agents, representatives, successors, heirs and assigns (collectively “Releasee’s”) from liability for any injuries, illness, infections, death, damages or claims arising due to my attendance and/or participation at the workshop.

Further, in light of the ongoing spread of COVID-19 based upon current recommendations by the Center for Disease Control (CDC) and by the State of Maryland Governor’s Order, individuals who fall within any of the categories below should not participate in the in-person event - by registering, you certify that you do not fall into any of the following categories: 1. Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among others; 2. Individuals who have traveled at any point in the past fourteen (14) days either internationally or to a community in the U.S. that has experienced or is experiencing sustained community spread of COVID-19; or 3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

DUTY TO SELF-MONITOR AND CONTACT TRACE: Participants and volunteers agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact Forever Maryland immediately if they experience symptoms of COVID-19 within 14 days

after the workshop. Attendees agree to participate in any contact tracing activities deemed necessary by local health officials.

NON-OFFICIAL CONFERENCE VENUES: Participants acknowledge that Forever Maryland has no ownership or control over venues and events happening around the workshop and that participation in events outside of Forever Maryland's official workshop program is a health risk discouraged by Forever Maryland. Forever Maryland is not responsible for any risk or liability assumed by participants who attend such events.
